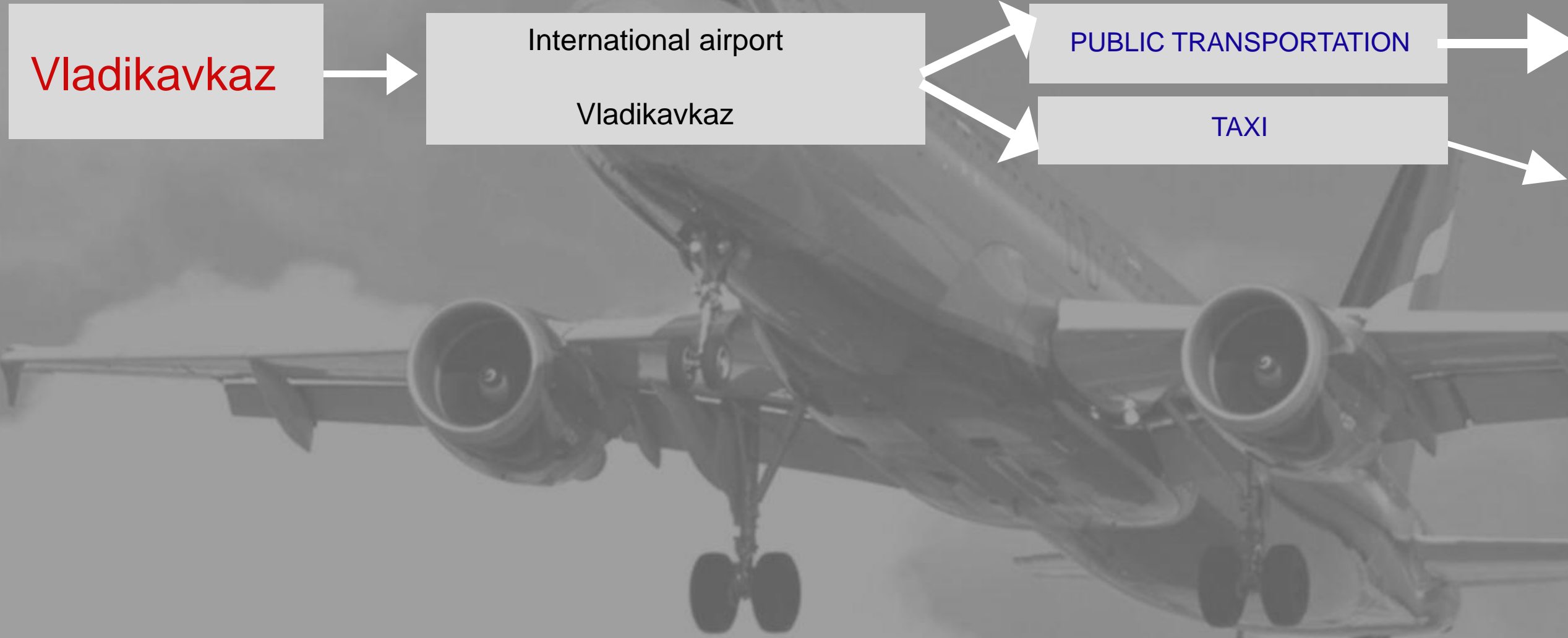

APPLY FOR A RUSSIAN VISA

REGULATORY FRAMEWORK ON VISAS FOR RUSSIAN CITIZENS

In accordance with article 2 of the Federal Law No. 115-FZ of July 25, 2002 “On the Legal Status of Foreign Citizens in the Russian Federation”, a foreign citizen is a natural person who is not a citizen of the Russian Federation and who disposes of the proofs of his/her possession of the citizenship (of his/her being a subject) of a foreign state; stateless person is a natural person who is not a citizen of the Russian Federation and who has no proofs of his/her possession of the citizenship (of his/her being a subject) of a foreign state.

In accordance with article 25.2 of the Federal Law No. 114-FZ of August 16, 1996 “On the Procedure for Exit from and Entry to the Russian Federation”, the visa may be for single, double and multiple entry.

In accordance with article 25.6 of the Federal Law No. 114-FZ of August 16, 1996 “On the Procedure for Exit from and Entry to the Russian Federation”, depending on the purpose of entry of a foreign citizen into the Russian Federation and the purpose of his/her stay in the Russian Federation, ordinary visas are classified under the following categories: private, business, tourist, student, working, humanitarian and visas for entry into the Russian Federation for the purpose of getting asylum, obtaining a permit for temporary residence in the Russian Federation or getting conferment of citizenship of the Russian Federation.

Article 25.9. When a foreign citizen or a stateless person enters the Russian Federation, he/she shall receive and fill in a migration card. The migration card shall be surrendered (returned) at the checkpoint at the State Border of the Russian Federation when the foreign citizen or the stateless person exits the Russian Federation.

In accordance with article 18, section II, in the Russian Federation, depending on the purpose of entry of foreign nationals into the Russian Federation and the purpose of their stay in the Russian Federation, visas of the following categories may be issued: a) diplomatic visa; b) official visa; c) ordinary visa; d) transit visa; e) temporary residence visa.

SELECTION OF THE TYPE OF VISA AND DETERMINATION OF THE PURPOSE OF STAY*

* In accordance with the appendix to the joint order of the Ministry of Foreign Affairs, the Ministry of Internal Affairs of Russia and the Federal Security Service of Russia No. 19723A/1048/922 of December 27, 2003

TYPE OF VISA: TOURIST

PURPOSE OF VISIT:

TARGET TOURISM

The period of validity: up to 30 days

For those who visit Russia for tourism purposes on a specialized tour for health check-ups or medical consultations

TYPE OF VISA:

BUSINESS

PURPOSE OF VISIT:

MEDICAL TREATMENT

The period of validity: up to 90 days

For those who visit Russia for medical treatment, health check-ups, medical consultations with an official invitation received from a health facility (except target tourism for the purpose of treatment) and emergency treatment.

TYPE OF VISA: PRIVATE

PURPOSE OF VISIT:

SPECIAL CASES

The period of validity: up to 90 days

For those who travel to Russia for emergency medical treatment or due to a serious illness or death of a close relative.

GETTING AN OFFICIAL INVITATION TO VISIT RUSSIA

The medical facility, having confirmed the possibility of your treatment, may execute an official invitation for you to enter Russia and may resolve the issue of migration registration.

EXECUTION OF REQUIRED DOCUMENTS FOR OBTAINING VISAS BY THIRD PERSONS

If a tour operator or an assistance organization is handling the issue of your treatment in Russia, please entrust the organization with execution of documents to obtain visa.
